### Speeding Traffic on Road

*Safety of pedestrians a concern for many*

At many past Association meetings, concern has been expressed about the excessive speed of some traffic on the Springy Pond Road. Not only was this issue discussed last year; this has been a common concern for many residents throughout the years.

Since Springy Pond Road is a private road, a speed limit cannot be enforced by local law enforcement officials. The most we can do is pass the word along to those that travel the road to drive at a reasonable and prudent speed. Special care must be taken where the road passes by residences along the shoreline. In these areas, the road is narrow, sight distances are limited, and traffic is entering and exiting the road from driveways. The road is not only used by vehicles, but by pedestrians and cyclists as well.

The problem of excessive speed is not only attributed to certain the Springy Pond residents, but with the visitors as well. Please inform your visitors that they must share the road with pedestrians and cyclists and should always travel the Springy Pond Road with this in mind. ★

Please make a point to pay your dues. Paying during the winter months has made a difference by having working cash when we need to start with spring work on the road.

Excessive speed continues to be a factor on the road. As you have noticed, there are many walkers, huge dump trucks, children, etc, so please drive slowly and remind all who visit you to do the same.

Annual Clifton Clean-Up day will be the same weekend as the dinner, July 16 & 17. This is a time to take all of your bulk waste to the Clifton Town Office. Nothing hazardous such as computers, refrigerators, etc will be accepted. That should happen in the fall.

Remember also that the dumpster at the Town Office is for us at the Pond to use. Have your trash there by early am on Mondays. There is no longer trash pick-up at the end of the camp road, and over the course of the summer, a few bags will end up there. It is not always the "Pond People" that place it there, but just a reminder to anyone who may be staying here and not realizing we need to take trash to the dumpster.
